## Interprofessional collaborative practice for practicing speech-language therapists in Hong Kong

We are Leung Wai Ying, Kelly and Tang Hei Yung, Blanche, Year 4 undergraduate students studying Bachelor of Science in Speech and Hearing Sciences in the Faculty of Education at the University of Hong Kong (HKU). Correspondingly, an invitation email containing a link to the online questionnaire will be given to your association to distribute to the practising speech-language therapists to complete. It will take them 15-20 minutes to complete the questionnaire. The participation of your association and practising speech-language therapists can choose to withdraw from the study at any time without negative outcomes.

According to the University's policy on the ethical conduct of research, we are writing to ask your consent for these procedures. The information obtained from speech-language therapists will be handled with high confidentiality and anonymity. That means the association's name and the speech-language therapist's name will not be included in any parts of the questionnaire, as well as not used in the final written paper. The data collected will only be used for the paper and all the consent forms and questionnaires will be destroyed 3 years after completion of the study. All the data will be stored in a passcode-protected computer in the Academic Unit of Human Communication, Development, and Information Sciences, HKU. We will only have access to the data collected from the association and the speech-language therapists to protect the confidentiality of all the participants in this study.
